Esplanade St., Cuero, TX. The purpose of the meeting is to conduct regular District business and hear public comment and consider possible issuance on the following permit applications.

Non-Exempt Drilling and Operating Permit Application from PSS Real Estate, LLC. The application is for the beneficial use for Commercial purposes and requests an annual production of 6 Acre-Feet of water. This property is located on US Hwy 87 S. near Cuero and involves 12.485 acres.

Operating Permit Amendment Application from Tracy Metting. The application is for the beneficial use for Irrigation purposes and requests an increased annual production from 28 acre-feet to 44.43 acre-feet of water per year from this water well. This would be an annual total of 69.43 acre-feet of water from two water wells. This property is located on VFW Rd. near Yorktown and involves 138.86 acres.
